

## ORDER

Delhi Teacher Training College, 340, Deenpur, Bijwasan Road, Najafgarh, New Delhi 110 043 had submitted an application to the Northan Regional Committee of National Council for Teacher Education for grant of recognition for starting B. Ed. Course of One year duration in terms of Section 14(1) of the NCTE Act, 1993.

Nov therefore, in exercise of the powers vested under Section 14(3)(a) of the NOTE Act 993, the Regional Committee hereby grants recognition to Delhi Teacher Training College, 340, Deenpur, Bijwasan Road, Najafgarh, New Delhi 110 043 for B. Ed course of ( e year duration w.e.f. 5th November 2004 with an annual intake of 100 (One Hun ed) subject to fulfillment of the following before commencement of the session :-

pointment of the faculty members duly qualified and staff as per the (a) rms of NCTE / State Govt. / University is to be completed before the mmencement of the session.

ne countersigned statement of all faculty members from the Registrar of (b) e affiliating university should be submitted before the commencement the academic session.

(c) he institution shall adhere to all the other regulations and guidelines as amed by NCTE from time to time.

(d) he institution shall within one month of the receipt of Recognition order, onvert the Endowment Fund account into a Joint Account in the form of DR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the degional committee.

(e) hat the Reserve Fund for an amount equal to three months salary of the achers & staff be created within one month from the date of issue of is order and maintained in the form of FDR in favor of the anagement/institution, for a period of not less than sixty months (five ears) in a Nationalized Bank.

on-compliance of the above mentioned conditions shall cause action ader section 17(1) of NCTE Act. 1993.

- 3. Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating Body.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a <u>Self-Appraisal</u> Report at he end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
